Booth Details:

- Fee is for space only. You must bring your own booth setup including canopy, tables, and chairs.
- Set up time begins at 7am. Please have the booth ready by 9am.
- Tear Down begins at 3pm – **ALL BOOTHS REMAIN IN PLACE UNTIL 3PM.**
- **NO VENDOR ENTRY AFTER 9AM.**
- All EZ-ups must be Fire Department approved and weighted down at all times per fire code. NO EXCEPTIONS.
- Electrical source available for \$15. You must supply your own extension cord(s) – recommend 100 to 200 feet.
- NO OPEN FLAMES or cooking under EZ-ups or canopies permitted.
- Food trucks must be Fire Department and Health Department approved. Must display health card. *
- CA Retail Sales License: If you are selling products, you must display your California Retail Sales License.
- Business License – If your selling products, and you are not a licensed business in the City of Wildomar, you must obtain a City of Wildomar Business License <https://www.wildomar.gov/218/Business-Registration> - The City will not charge you for this one-day license.
- Information booth only – No business license is required.
- Reminders and details regarding Check-In and Set-Up will be emailed prior to the event.
- Spaces are limited. Submit early!
- Thank you for following the rules. The event is on City of Wildomar property. Failure to abide by City requirements will result in asking you to leave the show.
- Your application is NOT APPROVED until completed application, payment and requested documents are received by The Nature Education Foundation.
- Please include a picture of your booth/food truck with your application.
- **No refunds for no shows or cancellations, or if you are asked to leave. • DEADLINE TO APPLY –May 15, 2026**

Insurance Requirements:

- You may be asked to provide evidence of insurance, naming the City of Wildomar and The Nature Education Foundation as also insured. This is a requirement for food trucks.
- You must be willing to sign a Release of Liability, naming The City of Wildomar and The Nature Education Foundation.

Understanding the Permit Process for this Event:

- All approved vendors must be listed on the Event Permit Application submitted by the City to the County of Riverside.
- Timely submittal of your application to The Nature Education Foundation will allow us to ensure your business is listed properly, and we can assist you if something is missing.
- TNEF will be covering the permit fee for your business to be included in the County Permit for this event.
- Please be sure your Retail Licenses, Business License and Health Placards and, where needed your Certificates of Insurance, are up-to-date and at-the-ready.
